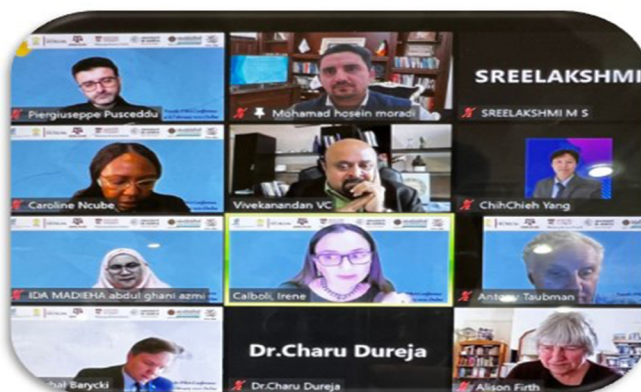

One of the challenges of businessmen and entrepreneurs in exporting importing is the lack of knowledge and information about the domestic laws of the destination countries .

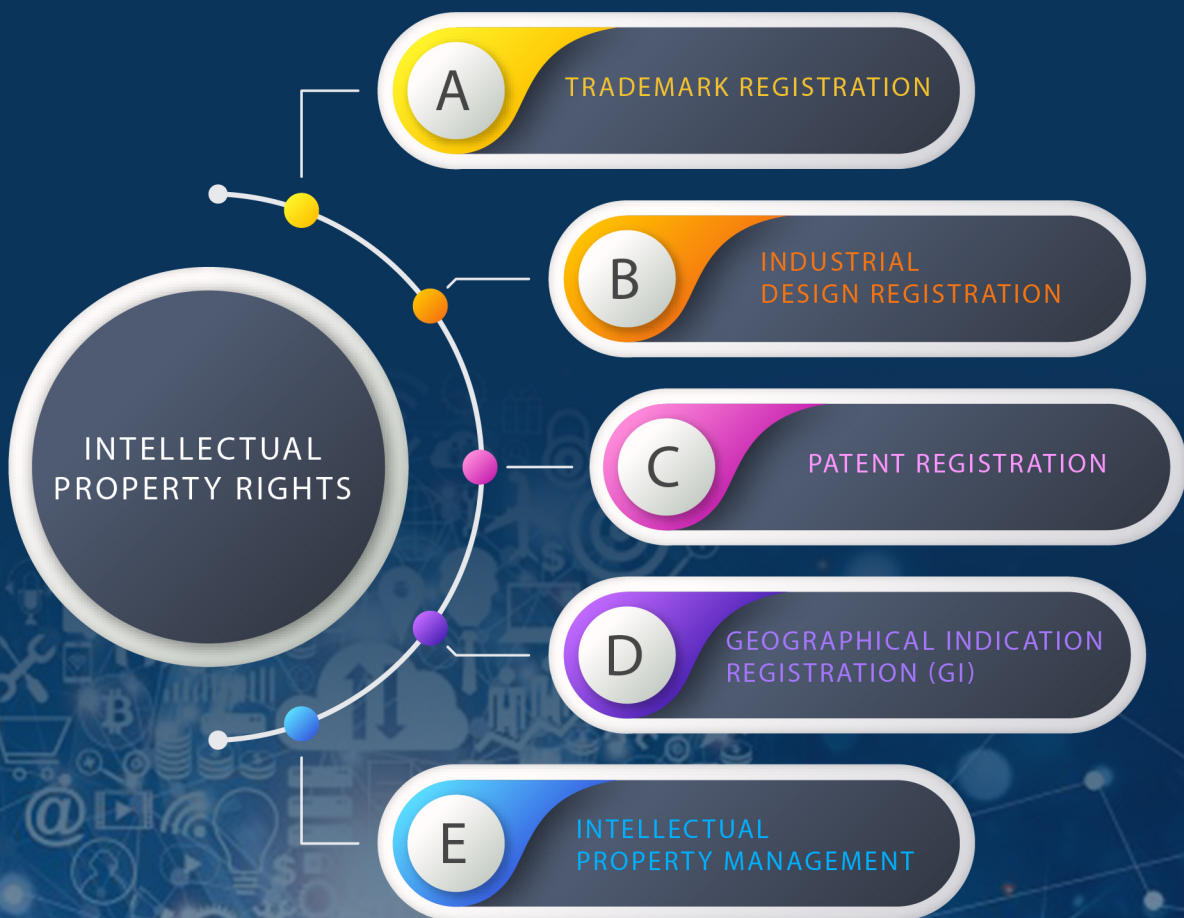

Resolving identified legal complications through the creation of a codified legal structure and appropriate training



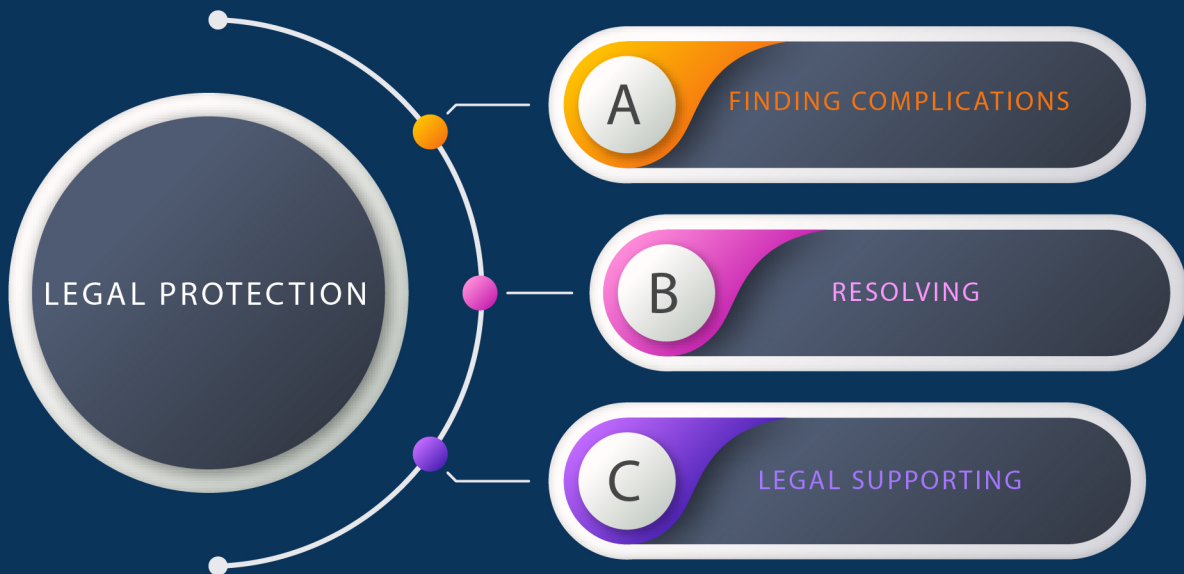
The third phase
